## The order of publication of materials in the scientific journal "Law and Society" № 4 for 2025

The journal "Law and Society" is included in <u>Index Copernicus International</u> scientific base (**Republic of Poland**).

Based on the Order of Ministry of Education and Science of Ukraine <u>No 1643 dated</u> <u>28.12.2019 (annex 4)</u>, the journal is included in the List of professional editions of Ukraine (category "B") in the area of legal sciences (D8 – Law, D9 – International Law, K9 – Law Enforcement Activities)

1. Works publishing in Ukrainian or English, up to 12 sheets (inclusive) are accepted.

2. The manuscript of the article must have the following elements:

- UDC;
- section name;
- last name and initials of the author, scientific degree, position;
- article title in Ukrainian;

- extended abstract in Ukrainian and English, each with 1800 printed characters;

- Keywords;
- the main text of the article;
- literature.

3. Articles are accepted for publication in the following sections:

- state and law development: issues of theory and constitutional practice;
- civilistics;
- business law and process;
- labor law, social security law;
- environmental law;
- administrative law and administrative process, information law;
- finance law;
- issues of criminal law, criminology and criminal law;
- criminal procedure law and criminalistics;
- international law;
- tribune of a foreign scientist.

4. The main text of the article consists of the following structural elements:

**Introduction** (statement of the problem in general form and its relation to important scientific or practical tasks; analysis of the latest researches and publications in which the problem is solved and which the author bases on, the selection of previously solved parts of the general problem, which is devoted to the article);

Goal setting (formulation of goals of the article);

**Results of the research** (presentation of the main research material with full justification of the scientific results obtained);

Conclusions from this study and prospects for further intelligence in this area;

The literature is designed according to state standards.

These elements are highlighted in the manuscript in bold.

## Prohibition of using scientific works of the occupying country

It is prohibited citing and including in the reference list russian-language contributions published in any country, incl. papers written in other languages but published in russia and belarus.

5. The article should be typed in a Microsoft Word text editor. Fields on all sides -20 mm. Font – Times New Roman 14 at 1.5 intervals.

References are made directly to the text. The square brackets indicate the order number of the source used, and the comma through which the specific page.

*Warning!* The editorial board accepts articles of students only in co-authorship with the scientific supervisor.

6. The cost of printing an article up to 12 sheets is **1400 UAH**. If the amount of work exceeds the specified, the cost of the additional page is 50 UAH. The publication fee covers the costs associated with review, proofreading and editing of articles, layout of the collection and placement of its electronic version.

The electronic version of the journal is timely placed in public access on the publication's website.

If desired, the author of the article can order a **printed copy** of the magazine. The cost of a printed copy is **UAH 800**, which must be paid in addition to the publication fee.

7. The following should be submitted to the e-mail address <u>mailto:info@pravisuspilstvo.org.ua</u> in issue  $N_{2}$  4 for 2025 by **July 31, 2025**:

- electronic version of the article;

- certificate of the author, filled in <u>by the link</u>. or using a QR code

After receiving the article, the editorial board conducts its internal anonymous peer review and check for plagiarism.

## Academic integrity

The articles are checked for plagiarism using the software <u>StrikePlagiarism.com</u> developed by the Polish company <u>Plagiat.pl</u>.

The electronic version of the magazine will be posted on the website until October 31, 2025.

The printed version of the journal will be sent to authors of articles who order a printed copy by November 28, 2025.

The responsible secretary will send the answer about the decision on publication with the requisites for payment of the publication fee to the author within 2-3 days.
